
Our mission is to Keep Alaska Moving through service and infrastructure.

How Does Inflation Affect Projects?

- Increase in Price of Construction Materials
- Surge in Fuel Costs
- Rising Labor Costs
- Supply Chain Issues uncertain delivery dates
- Higher Machinery Hire Rates

Contractor Bid prices reflect all these factors




